MBA FOR LAWYERS (Advanced Course Offerings) You went to law school. You may not have gone to business school. Having the capability to understand business and financial concepts is a real advantage. As corporate counsel, your job often includes advising management on legal issues that impact important business decisions. Doing this effectively may require you to understand key financial concepts, such as information presented in financial statements and valuation methods used in strategic decision making. In collaboration with Deloitte, we will host an advance financial acumen program. The most effective in-house attorneys understand, not only the breadth of legal issues facing their companies, they also recognize the importance of how those issues affect strategic business decisions.

The program will begin with a refresher of the basics of accounting concepts, financial statements, and US GAAP accounting principles as well as valuation principles and theory (i.e., what is valuation, who needs it, and common litigation issues). The program will feature an opportunity for you to apply what you have learned in the context of a fictitious corporation – discussing their financial statements as well as equity analysts’ reports and valuation principles relevant to the health care and sports/entertainment industries.
